Deferred Payment Financing Option - first payment due for Class A Licenses selecting monthly installment payments (due on 1st of the month for 60 months.)

September
2010

Statutory Deadline (90 days from July 1, 2010) for all Class A and Class B Licensees to meet their respective requirements as to operating a Class A or Class B Retail Outlet.

October
2010

Deferred Payment Financing Option - first payment due for Class A Licenses selecting quarterly installment payments (and due every 3rd month thereafter for 60 months.)
